Special Orders - Returns & Restocking

- A purchase order is required from all customers for taxation and tracking purposes.
- We will gladly try to source any item that you need for your operation/plant!
- Our standard stock items are listed in our Web Pages.
- Items not listed on our website would be considered as "Special Order."
- A down payment may be required to secure delivery of the part from our sources.
- Special order items are normally "Non-Returnable".
- If we can return a special order item to our source, a restocking fee of 40% plus shipping costs, will apply.
- If we cannot return the special order item to our original source, then the item will be deemed - non-returnable - and the full invoiced price will apply.
- For items that are standard stock, and cancelled before shipping from our warehouse - no fees will apply.
- For items that are standard stock and returned within 30 days, a 10% restocking fee will apply.
- For items that are standard stock and returned after 30 days, a 55% restocking fee will apply.

Payment - Taxes - Billing and Overdue accounts

- We do not process credit cards, but use Paypal as our credit card processor.
- A service charge of 3.5% will added to the invoice, to cover Paypal fees.
- Canada - EFT, Interac Etransfer or wire transfer are the preferred methods of payment. USA - Wire transfer or Paypal are the only acceptable forms of payment.
- We do not accept cheques (Ancient Papyrus Documents) from outside of Canada.
- Finance charge of 2% per month (28.8% per annum) on all over due accounts after 30 days.
- Any and all costs and fees (legal /collection /court) to recover monies owed to Borrowman Electric Ltd. for overdue accounts will be added to the overdue balance of any account owed.
- Borrowman Electric Ltd. reserves the right to retain ownership of all parts sold, until invoices are fully paid and clear.
- GST/HST will be collected and remitted as per Canadian Tax Laws.
- We are only registered to collect BC PST.
- Inside BC, to be exempt from BC PST, we must have a copy of your exemption certificate.
- PST outside of BC is the responsibility of the purchaser to remit, as per your province's tax laws.
- International customers do not pay Canadian taxes.
- You are required to remit your customs, duties and taxes as per your country's taxation laws. Wire Transfer is the only acceptable method of payment from outside of Canada.
